# 11<sup>TH</sup> TRIENNIAL GENERAL COUNCIL OF AIBOC A GRAND SUCCESS – NEW LEADERSHIP TAKES OVER

## INAUGURAL SESSION – 17<sup>TH</sup> MARCH 2017:
