## **UFBU STRIKE ON 28<sup>TH</sup> FEBRUARY, 2017**

The Conciliation Meeting in response to the Strike Notice of UFBU for strike on 28<sup>th</sup> February was held today at 11.30 a.m. by Sh. Anil Kumar Nayak, CLC in his Chamber in Shram Shakti Bhavan, New Delhi. Representatives from constituents of UFBU, except from NOBO and NOBW were present in the meeting. AIBOC was represented by Com.Harvinder Singh, Com. Ajay Jaitley, President of Delhi State Unit and com. Pankaj Kapoor, Treasurer, AIBOC. Sh. S.R. Mehar, Dy. Secretary, D.F.S. represented Government in the meeting. Sh. K.S. Chauhan, Sr. Vice President and Sh. Atul Gautam, Sr Advisor were present on behalf of IBA. After brief introduction, CLC asked UFBU to present their case. All issues covered in the strike notice were presented and explained by us. IBA & Government representatives submitted their views. In brief they argued that most of the issues are apprehensions only and in other cases Govt./IBA is in the process of sorting out the issues. After listening to both the parties and considering the views of both sides, CLC made a request to unions to withdraw the strike. CLC advised DFS and IBA also to initiate the dialogue for settlement of the issues so that strike can be averted. In view of no positive response or commitment, UFBU stands on its decision of strike. We call upon our rank and file to make the preparatory programmes and Strike on 28<sup>th</sup> February a grand success.

2. The issues listed out in the strike Agenda are very important and serious issues. Despite our best efforts to sort out and bring these to a logical conclusion, the Government has turned a blind eye to the issues dear to all of us. Therefore, the UFBU has taken the only path, the right path of agitation and strike. Let us all mobilise officers and irrespective of the scales and grades and ensure 100% success of the strike.
