## STAFF: OFFICERS: INTER-SE-ANOMALY IN FITMENT ON PROMOTION

With further reference to your Circular NU/CDO/P&HRD-PM/15/2017-18 dated 23<sup>rd</sup> May, 2017 on the captioned subject, we invite your kind attention to the Corporate Centre Circular No. PA/CIR-71 dated 12<sup>th</sup> June, 1991 para No. <u>3</u> a copy of which is enclosed for your immediate reference.

- 2. In terms of the above Circular "If the increase in basic pay of the officer on promotion is equal to one increment only and if he was stagnating at maximum stage or at stagnation increment stage, the date of annual increment which has to be fixed as anniversary of promotion will be preponed by 1 to 4 months depending upon the number of years he was stagnating at that stage."
- 3. In view of the above, whenever an officer is promoted one scale to another scale after reaching the maximum in the previous scale, the date of increment in the higher scale/new scale shall be anniversary date of promotion. This annual date of increment shall be preponed by 1 to 4 months depending on the number of years the officer has stagnated in the previous scale.
- **4.** We request you to kindly incorporate this clause to your above referred circular No. CDO/P&HRD-PM/15/2017-18 dated 23<sup>rd</sup> May, 2017 and issue a Comprehensive Circular, to avoid any operational error/mal interpretation.

Please do the needful at the earliest.
