## SEMINAR ON FITMENT FORMULA <u>10<sup>™</sup> BIPARTITE SETTLEMENT</u>

The Federation had organized a seminar in connection with the settlement of fitment formula in respect of the 10<sup>th</sup> Bipartite Settlement. Our members are aware that the Fitment Formula in State Bank of India will be decided through an agreement between the Federation and the State Bank Management from time to time after the Bipartite Settlement at the industry level, taking into account the special features of State Bank of India salary scales and the settlements at periodical intervals.

The Federation would take into account the special features as well as the historical background of the fitment formula and decide the fitment as per our own requirement in order to ensure the protection of the emoluments and the special features of the salary scales etc. The Federation had organized a seminar in order to seek the views of the affiliates and invited those who were responsible for looking after the fitment cases in their own circles.

**3.** In response to the request more than 15 participants from the various circles assembled in the headquarters of the Federation at Bangalore on 3<sup>rd</sup> May, 2016. The participants came out with their own experience and insight and gave suggestions to be taken up by the Federation while discussing on the issue of the Fitment formula with the Corporate Center.

**4.** The seminar was attended by Com. Y.Sudarshan, the General Secretary of the Federation who in his introductory remarks gave a brief account of the purpose of the seminar and requested the participants to contribute their experience and views.

G.Muthuswamy, the former Senior Vice President of the Federation and also the General Secretary of SBIOA(K) who had long standing experience and had contributed his mite to the various bipartite settlements and also the fitment formula agreement between the Federation and the State Bank Management for more than two decades was also present.
