QUOTE:

Our Confederation has been in forefront in opposing the policies of the Government of the times which lead to destabilize the country through concentration of powers in private hands, foreign investments in strategic sectors, disinvestments, privatization etc. After the present Government took over, implementation of these policies were intensified in the name of reforms. Considering the gravity of the situation, our Confederation formed a Sub-committee to go into the details of the consequences and to suggest a concrete and prolonged agitational programme against so called reforms. Many programmes suggested by the Sub-committee and approved / fine-tuned by the Executive Committee of the Confederation in its meeting held on 6th April, 2016, at Bhopal and Working Committee of the Confederation in its Meeting held on 2nd June, 2016 at Chennai have already been successfully implemented. Our poster drives, agitations, rallies, seminars, symposiums and education to common man through Press Releases and pamphlets also have drawn the attention of all concerned. Our memorandums to Hon'ble Prime Minister / Finance Minister of India and leaders of the opposition parties were also the part of our long drawn struggle.

One of the major decisions taken by the Confederation as a part of Save Public Sector Bank was to organize a "March to Parliament on 9th August, 2016". The Executive Committee fixed a target of participation by atleast ten thousand members from various Affiliates in this historic march.
