### ERSTWHILE BHARATIYA MAHILA BANK LTD EMPLOYEES: HRMS

We invite your kind attention to our Joint letter No. SPL/7/2016 dated 29.05.2017 and representations in various CNC's on the problems faced by the employees of erstwhile Bharatiya Mahila Bank Ltd. Though the issue was taken up in right earnest by the Corporate Centre, the HRMS portal is not available with all the options to these employees even after 15 months of acquisition of BML by State Bank of India. These employees have been taking up the issue with HRMS individually but the issues remain to be addressed. Some of the issues are detailed hereunder:

1)As Leave Balances are **not updated in HRMS as on 31st March, 2017**, these employees are not able to apply for leave. 2)Mobile handset reimbursement.

3) Despite the Circular No. CDO/P&HRD-IR/32/2017–18, the employees are unable to avail Festival advance.

4)Briefcase reimbursement is not available in HRMS.

5)Utility Items also not available in HRMS.

6)Not able to take JAIIB/CAIIB increment as well as Honorarium, Fees etc.,for other IIBF examination/certifications. 7)WELFARE BOUQUET (Holiday Homes, Guest House Booking) also not available in HRMS.

2. It is further reported that the Offline ICT request given in eBMBL, also not updated in ICT portal.

3. We therefore request you to address the above issues urgently.
