### EXECUTIVE COMMITTEE MEETING OF ALL INDIA STATE BANK OFFICERS' FEDERATION

Our members are aware that the 27<sup>th</sup> Triennial General Council Meeting of the Federation was held at Chennai on 23<sup>rd</sup> to 25<sup>th</sup> June, 2018 in a grand manner. The nostalgic events that were witnessed by our members who attended from all parts of the country is still green in our memory. The Banking Industry is now busy in tackling the issue of NPA's etc. The Federation is holding its first Executive Committee Meeting after the 27<sup>th</sup> General Council on 23<sup>rd</sup> September at Ahmedabad. In the meanwhile, we had a few rounds of follow-up meetings and discussions with the Management on a number of issues that are to be resolved at the bank level. We are also closely watching the developments at the industry level as regards the issue of the Salary Revision and other related matters. The opportunity will also be utilized to discuss threadbare the future course to be adopted by the Federation in regard to some of the issues related to the Salary Revision in particular the issue of mandate etc., Com. Soumya Datta, the President of the Federation being the General Secretary of the Confederation will have an opportunity to brief the entire Executive Committee about the recent developments both at the IBA as well as the Government level in regard to the efforts made by him in pursuing the various major issues pending at the IBA and Government levels.

2. The Executive Committee will deliberate on all the major issues connecting with the banking industry as well as the issues relating to the State Bank of India. In the meanwhile, we have requested the Bank to convene the next Central Negotiating Council meeting in order to pursue some of the long pending issues before the Corporate Centre.

3. The Executive Committee will also review the implementation of some of the issues sorted out during the last couple of days in particular the issue of Work life Balance, the Inter Circle Transfers, Issues pertaining to FO (Agri – RMRO's) and the review of the Disciplinary Proceedings in certain areas and guidelines issued by the bank as well as the problems in regard to the implementation of the same.
