ADDITIONAL LEAVE/SUBSISTANCE ALLOWANCE TO OFFICERS SUFFERING FROM CANCER

We solicit your kind reference to our letter No. 8104/50/17 dated 14.7.2017 requesting for introduction of additional sick leave of 6 months to officers who are forced to exhaust their leave for availing treatment for cancer.

- 2. While this is yet to be considered by the Bank, our affiliates have reported that number of officers suffering from Cancer has increased substantially and a few of them are required to remain on Extra Ordinary Leave on Loss of Pay for a considerable time after exhausting all leave. They are unable to meet their financial obligations towards the family commitments including the education of their children due to huge expenditures incurred on treatment over and above the reimbursable expenses.
- **3.** In view of the above, we request you that if sanction of additional sick leave in such cases is not feasible, Bank may consider extending subsistence allowance to such officers till they are able to resume their duties. This may be considered as gesture of goodwill by the Bank towards the Officers as ;
 - (a) Globally such provisions find acceptance under social security schemes.
 - (b) Such scheme if introduced will boost the morale of all the employees and they will feel the comfort of security.
 - (c) It will not entail much of cost to the Bank to introduce such social security scheme considering the benefit it will accrue in terms of employee satisfaction and reputation the organization would earn as a caring employer.
- **4.** As Compassion has been the backbone of all our endeavour and forms the pillar of each of the HR initiatives that the bank takes, such beneficial provision for an ailing Officer will not only facilitate the concerned Officer regain his health but will also be of great help to family members of such Officer.

We therefore request you to take a favourable view in this regard.
