After that, many members from different establishments of the Module delivered their deliberations on Secretary's Report and Statement of Accounts. Com Agni Pratim Halder (IFB) vouched for additional officer in single-officer Branches, enquired about FIMM vertical, demanded for increase of ceiling of batteries and mobile handsets, annual health check up facilities for all members irrespective of ages. Com Tapan Das (CCGRO) spoke about the new transfer policies, anonymous complaints and its bad effects. Com Mrinmoy Basu (CB, Jeevan Deep) told about the sudden changes in CBS and its after effects and suggested for providing soft copies of the Annual Report for all members, demanded reimbursement of club membership subscription & physical fitness expenses. Com Argha Nandan (SARB, Kolkata) insisted on maintaining a second line at least to provide skeleton service by the HR Department at SAMBs. He also requested for introducing online holiday home booking. Com Pranab Kumar (GMU) told about the disadvantages of merger of banks.
