VIGILANCE/DP CLEARANCE

We express our sincere gratitude to the bank for issuing requisite clarifications in the matter of "Contemplated or Pending Disciplinary Action" vide circular No.CDO/P&HRD-PM/36/2018-19 dated 18.08.2018, that we sought for over pretty long time, which paved the way for opening and clearance of several sealed covers, kept pending for many years, which was an iniquitous system that affected the career of many of our officials. The declaration of results kept in the sealed covers benefited hundreds of officers who got their back dated promotions.

02. There have been massive changes in the bank in the past two/three decades in its structure, policy, system and procedure, etc. to cope with sweeping changes in the external factors viz. economic, regulatory guidelines, competition, market dynamics etc. However, we observe that there is a need to revise the guidelines on Issue/Obtention of

Vigilance/DP clearance for the following reasons:

- i. Guidelines on obtention of Vigilance/DP clearance were issued in the Conference of Deputy General Managers (Vigilance) on December 12th, 1998. Many of them are redundant now and have become obsolete in view of the changed scenario over a period of 22 years which require proper revision at the earliest to make it a useful repository of guidelines as per the users' requirement.
- ii. Though distinct guidelines are available in the bank for various related purposes, they are not available at one place resulting in confusion/ over lapping of instructions.

For example: clarification regarding DP/Vigilance for sanction of Housing loans are available at SI.No.1.25 Page No.33 and for Personal Loans at 3.9 Page No.58 of HR Manual 3.

In this digital era, the guidelines should be available at one place in a logical order or sequence to ensure easy access to the same with optimum ease and convenience.

03. In the above backdrop, we request you to revisit the existing guidelines with a pragmatic approach and arrange for issuance of consolidated and detailed guidelines for seeking and issue of vigilance/DP clearance for various purposes.
