COM. SUBHASH SAWANT IS NO MORE

We regret and feel very sad to inform that Com. Subhash Sawant, General Secretary of Indian National Bank Employees Federation, one of our constituent Unions, passed away today early morning in Mumbai in a hospital where he was undergoing treatment for Covid19. He was admitted to the hospital on 28th August but unfortunately he could not come of the infection and succumbed to the same.

Com. Sawant participated in the discussions with IBA along with us on 22-7-2020 and signed in the MoU. He also participated in the virtual meeting with IBA on 20-8-2020. But he could not attend the discussions held on 28-8-2020 due to his hospitalisation.

Com. Sawant, as leader of INBEF, has been part of the industry level negotiations and is a signatory to the Settlements from 1995 from the 6th Bipartite Settlement onwards. For more than two decades, he was the General Secretary of INBEF. He was also associated with UFBU since its beginning from 1997. In every meeting, on every issue, Com Sawant had his views and was always frank and vocal in expressing his viewpoints. In the current negotiations for the 11th Bipartite also, Com Sawant was associated right from the formulation of the common set of demands till signing the MoU. It is very unfortunate that he got infected with Corona virus and became a victim to Covid19. We place on record our appreciation for his commitment and contribution to bank employees movement and convey our heartfelt condolences.
