### 6<sup>TH</sup> ANNUAL GENERAL MEETING OF AZC, CORPORATE MODULE HELD ON 10TH FEBRUARY,2021 AT 2<sup>ND</sup> FLOOR, CANTEEN HALL JEEVANDEEP BUILDING, KOLKATA

The 6<sup>th</sup> Annual General Meeting of Administrative Zonal Committee, Corporate Module, functioning under SBI Officers' Association (Bengal Circle), was held on 10<sup>th</sup> February,2021 (Wednesday). He informed the house that bank is intending to initiate stringent action against Corporate Loan defaulters. He elaborately discussed in the house about "Individual Insolvency" and "Bankruptcy".

Shri Rajnish Ranjan Roy, Deputy General Manager, SAMB-II, Kolkata, in his address requested the youngsters to come and work at SARG. He discussed about various aspects of SARG.

On being invited by the anchor of the meeting, the undersigned in his address mentioned that a wonderful 8th Joint Note could be achieved under the stewardship of Comrade Soumya Datta, General Secretary AIBOC & AISBOF during this pandemic even when DA for Central Govt. had been frozen. He described the various aspects of forthcoming Strike on 15th 16th March 2021. He informed the house that the Government is planning to sell out two PSU banks and One General Insurance Company to raise Rs.1.75 lacs crore but surprisingly the names of those two PSU banks have not been decided yet. He reminded that since the day of nationalization banking sector has been contributing for the growth of the country. Even when other sectors were standstill due to COVID,PSBs were there to serve the nation. Government is intending to sell these PSU banks to the crony Corporates. Then he mentioned some activities of Circle Association undertaken for the benefit of officers like conducting CNC meeting with Circle Management, Fitment Correction Campaign etc. He mentioned about the achievements during the year like Special Leave, financial assistance of Rs. 20,000/- to employees infected by COVID-19, 1 day salary for 6 working days, benefits of 8th Joint Note etc. Reminding the status of BSNL, he stressed on mobilizing the movement against Banks' Privatization.

After the open session of the meeting concluded, the business session was conducted by Com DibakarMazumder, Zonal President, AZC Corporate Module.
