**Dear Comrades,**

**Sub: Extending solidarity to the ongoing agitation programme of United Forum of Bank Unions—regarding**

You are aware that the United Forum of Bank Unions, the joint platform of all bank unions is in the midst of an agitation programme culminating in two days' bank strike on 15<sup>th</sup> & 16<sup>th</sup> of March, 2021 in support of the demand for strengthening of Public Sector Banks as well as opposing the proposed privatization of Public Sector Banks and other retrograde bank reforms.

The issues for agitation are neither confined to the interest of bank employees alone, nor such so called "reforms" are any isolated move. These are the regressive moves concerning not only the working class but every ordinary citizen of the country. So only a united and continuous struggle can compel the authorities to revisit and rescind. After all, PSU Banks are literally the custodians of the nation's family silver.

Against this backdrop, the All India Public Sector and Central Government Officers' Confederation (AIPCOC), the apex body of the officers organisations of all Central PSUs, Banks and Central Government Officers (i.e. NCOA, AIBOC & CCGGOO) convened a meeting on 06-03-2021. In the meeting, the AIBOC (All India Bank Officers' Confederation) leadership requested others to extend solidarity to the ongoing agitation programme. It was decided in the meeting that all three confederations would work in tandem under the banner of AIPCOC to fight against all such anti employee, anti-working-class & anti citizen moves of the authorities.

To strengthen the joint movement of Bank employees, it is requested to observe the following programmes:

1. Constituent organizations to stage Lunch Hour Demonstration on 15-03-2021 at all State Headquarters & other stations in support of the Bank employees on strike.
2. The State Units of CCGGOO to organize Day long Dharna programme on 15-03-2021 at the place(s) as per convenience in support of the Bank employees on strike.

In both the cases, measures may please be taken to invite the organizers/leaders of the Associations of other Central Government PSUs including Bank, LIC, GIC etc. to attend and speak on the occasion to appraise our members about the challenges the PSUs are facing today and also to turn the programmes more broad-based.

3. Leadership of constituent organizations and State CCGGOO leadership to attend the programmes of Bank employees on strike on 15<sup>th</sup>/16<sup>th</sup> March, 2021 as per convenience to strongly express the solidarity to their cause.
