Fraternal support to the strike and agitational programmes of:
All India Insurance Employees Association (AIIEA) and
Joint Forum of Trade Unions and Associations in PSGI (JFTUA)

Joint Forum of Trade Unions and Associations in Public Sector General Insurance companies have given a strike call on 17th March opposing privatisation and disinvestment of any PSGIC and other issues, while AIIEA has given a call of strike on 18th March 2021 opposing Amendments to LIC Act, 1956 paving way for IPO in LIC & FDI hike in Insurance from 49% to 74%.

02. We have been in constant touch with our fraternal organisations in the Insurance sector and other Central PSUs. It is a felt need that all of us have to join hands to put up a colossal resistance to 'Save Public Sector Undertakings'. Already various fraternal organisations in different sectors like Confederation of Central Government Gazetted Officers' Organizations (CCGOO) have extended solidarity and support to our agitational/strike programmes. We have to build a massive momentum in the days to come involving all sectors affected by the ill-conceived policies of the government.
