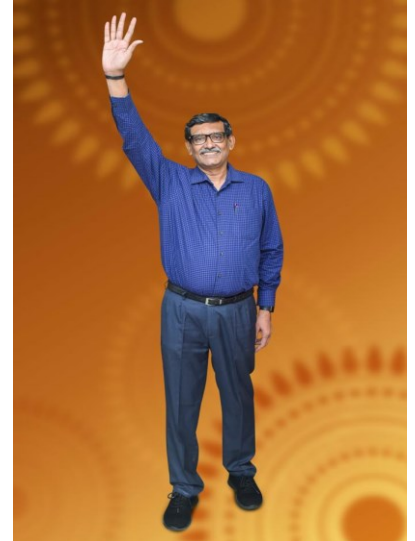
### COMRADE MURALI SOUDARARAJAN T, PRESIDENT, AIBOC DEMITS OFFICE

Comrade Murali Soundararajan T, President AIBOC, has demitted office on his attaining superannuation from Indian Overseas Bank today i.e. on 30<sup>th</sup> September 2022, after 39 years of illustrious and immaculate service career.

Born on 14<sup>th</sup> September, 1962, he commenced his journey in Indian Overseas Bank as Clerk and reported at Chennur Branch as his first posting. He is a Cost Accountant and Law graduate and became a banker by profession.

Com Murali traversed a long distance as a trade unionist after getting a promotion in the officer's grade in the year 1992 and contributed immensely to the cause of the officers' community. The very fact that he plunged into the trade union activities from the day he started his career in the Bank and has been at the centre stage of trade union movement for more than two decades speaks volumes of his leadership qualities and acumen.

He has put in great effort in instilling values such as determination, tolerance, equity, patience, honesty, and professional stewardship. He is an embodiment of optimism and hard work. He is not only a brilliant and completely dedicated and committed leader, but he is an exceptional human being. Com Murali is humility personified, a hallmark of a great trade unionist. His calm and composed demeanour and his commitment to espouse the cause of members in the face of extreme adversity has earned him accolades across rank and file. He was elected Assistant General Secretary, Central Office of IOBOA in the year 2002, and Joint General Secretary in 2005. Later on, he became Sr. Deputy General Secretary and continued up to 2014. He was elected President of IOBOA in August 2016 and General Secretary in January 2019 and held this position till his retirement. On 25<sup>th</sup> January, 2021, he was elected President of AIBOC and held this post with distinction till his retirement. His elevation as President, AIBOC in the last Triennial General Council has brought glory to his parent affiliate IOBOA, the first time ever in the history of the association, which has produced illustrious leaders, who contributed significantly for the growth and development of the Confederation.
