#### CALL FROM UFBU – OBSERVE ALL INDIA BANK STRIKE ON 30<sup>TH</sup> AND 31<sup>ST</sup> JANUARY 2023

All our unions and members are aware that while signing our wage revision settlement in November, 2020, it was agreed by the IBA that the remaining residual issues will be discussed and resolved at the earliest. Minutes were also signed by our unions listing out the various residual issues. Unfortunately, even though few rounds of discussions took place between IBA and the unions, none of the issues has been resolved despite a lapse of more than two years. In this backdrop call for All India Bank Strike was given by UFBU for 24<sup>th</sup> June 2022 but the same was deferred upon IBA agreeing to hold discussions with UFBU in connection to amicable resolution of the pending issues. But, unfortunately only two rounds of meeting with IBA has taken place so far and even after UFBU serving a letter to IBA after UFBU meeting held in Chennai on 15<sup>th</sup> December 2022, regarding urgent conduction of the said discussion, no positive move was observed from IBA in this regard till date. Furthermore, it is being observed that in all the banks, there is acute shortage of staff in most of the branches in all the cadres and the bank managements are not recruiting adequate number of staff to fill up these vacancies. With the result, the existing employees and officers are forced with heavy workload leading to frustration and de-motivation of the workforce.

In view of this, a meeting of UFBU was held at Mumbai to review and take necessary decisions, wherein it was unanimously decided to revive and relaunch our agitational programmes.

Following the UFBU circular no. UFBU/2023/01 dated the 12<sup>th</sup> January 2023 and Circular No.UFBU/2023/02 dated the 13<sup>th</sup> January 2023, and in our pursuit to achieve enormous success and desired outcome from the said All India Bank Strike on 30<sup>th</sup> and 31<sup>st</sup> January 2023, a meeting of UFBU, West Bengal State Unit was held at Ajit Sen Bhawan, 13, Crooked Lane, Kolkata – 700069 on 24<sup>th</sup> January 2023, wherein it was resolved to undertake the following agitational programs in order to make the All India Bank Strike 30<sup>th</sup> and 31<sup>st</sup> January 2023 a stupendous success.
