### **Extend support to the agitation in Bank of Maharashtra** **All India Strike on 9th and 10th February, 2023**

United Forum of MahaBank Unions in Bank of Maharashtra has given a call for agitational programmes including 2 days All India Strike on 9th and 10th February, 2023 on various demands and against the anti-Union approach of the management. The Union has approached us and requested to extend support to their agitation.

Earlier, there was an All India Strike on 27th January, 2023 which was a total success. From UFBU we extended our support to their strike. We also addressed our letter to the Managing Director of Bank of Maharashtra.
