Act by your good office.
- 03. We like to mention that in the year 2023, as per Govt. Notification No. 4331-F(P2) dt. 21.10.2022, the following festivals/occasions would have been included in the list under N.I. Act (List-I), if not falling on Sundays:
  - i) New Year's Day
  - ii) Birth Day of Guru Rabidas
  - iii) Birth Day of Shri Shri Harichand Thakur (Madhu Krishna Troyodashi Tithi)

- 04. Madam, we have observed in the recently published Govt. Notification No. 6112-F(P2) on 09.11.2023 that few of the above mentioned festivals have been included in List-I and other festivals/ occasions despite falling on weekdays might have been inadvertently excluded from List-I. We know that **New Year's Day (01st January)** and **Chhat Puja (07th November)** which have been excluded from List-I are celebrated by a large section of the employees in financial sectors along with their near and dear ones. Moreover, New Year's Day being an International Day and Chhat Puja being a sentimental auspicious day are celebrated by all sections of the society irrespective of any religion, caste and creed. Additionally, we also like to mention that "**Janmashtami**" is celebrated by the people all over the country including our State with huge enthusiasm and a deep sentiment is associated with it.
- 05. So, we fervently request you to kindly consider to include at least those three(3) festivals/ occasions in List-I of the Govt.
