Com. Ghosh requested CRS Com. Indranil Pyne to present the Secretary's report and the audited statement of accounts before the house..

Com. Pyne presented the Secretary's report. He requested to observe one minute silence in memory of the departed personalities of our country and our members during this period under report.. The functioning of AIBOC, AISBOF, Circle Association and AZC were discussed. He pointed out various issues which are being faced by the comrades of Howrah module. He also elaborated the achievement of the Circle Association and the AZC,Howrah during the period of reporting.
