COMRADE SUBHAS CHANDRA MONDAL, VICE-PRESIDENT **LAYS DOWN OFFICE ON 31.01.2024**

Dear Comrade,

Comrade Subhas Chandra Mondal, Vice-President, SBIOA (Bengal Circle) is demitting his office on the 31st January, 2024, following his retirement from Bank's service. Comrade Subhas Chandra Mondal, a veteran Trade Unionist, has been intrinsically associated with Trade Union movement for long years in various capacities. Over the years, he has been a dedicated and committed soldier of the Association having served in different capacities. He has discharged his duties with utmost dedication, sincerity, honesty and diligence and has significantly contributed for the growth and success of our beloved Association.

Comrade Subhas Chandra Mondal, joined the Bank on 16.01.1986 as Cashier-cum-Clerk at Kulti Branch under Zonal Office, Burdwan. He got involved with the activities of SBISA intrinsically and became Unit Secretary, SBISA at Barakar Composite Unit. After his transfer to Durgapur City Centre Branch in 1996, he remained active in Association Activities. He was promoted to officer cadre on 18.04.2004 and was posted at Ballygunge Railway Station Branch in June, 2004. Immediately after his promotion, he associated himself with SBI Officers' Association (Bengal Circle) and caught the eye of the then leadership as a potential leader and was co-opted as a member of Southern Avenue Composite Unit. In January, 2006, he became the Unit Secretary, Dhakuria Composite Unit. Later on he was elected as President, Region – I, AZC, Kolkata for the term 2007 – 2009. After his transfer to Dakshin Barasat Branch under the then Region – V, Kolkata Module, he was entrusted with the responsibility of Regional President, Region – V, Kolkata for the term 2010 – 2012. By dint of his devotion and sincerity in Association activities, he was identified to shoulder the responsibility an Administrative Zonal Committee Member, Kolkata in 2013; thereafter a Central Committee Member in 2014. He was elected as Asst. Secretary in the Central Committee in 2015. He was the natural choice for Asst. General Secretary, Bidhannagar in 2017 and in 2018 became Asst. General Secretary, South 24 Parganas. In recognition to his natural leadership quality, Central Committee entrusted him with the charge of Deputy General Secretary, SBIOA (Bengal Circle) in January, 2021 and he was elevated to the post of Vice-President of the Circle Association from 01.01.2024, a post he has held till his retirement. In the AIBOC, West Bengal State Committee, he was elected as Treasurer. It is noteworthy that the Central Committee, SBIOA (Bengal Circle), nominated him as Executive Committee Member, AISBOF in June, 2023.

Throughout his illustrious career in Association, he has proved his mettle with his calm and composed outlook, wisdom, wit and experience. He possesses the quality to establish and maintain close relationship with membership and functionaries of the Bank. He always played a key role in organising various programmes and activities of the Circle Association. His passion for Cricket is remarkable. He is an avid reader of works of Rabindranath Tagore & Sarat Chandra Chattopadhyay.

His retirement will leave a definite void in the Association, which would be very difficult to fill in.
