COMRADE TUSHAR KANTI GHOSH, VICE-PRESIDENT **LAYS DOWN OFFICE ON 31.07.2025**

Dear Comrade,

Comrade Tushar Kanti Ghosh, Vice-President, SBIOA (Bengal Circle), is laying down his office on the 31st July, 2025, consequent to his retirement from Bank's service. Comrade Tushar Kanti Ghosh, a veteran Trade Unionist and natural organiser, has been associated with Trade Union movement since long in various capacities. Over the years he has been a dedicated and committed soldier of the Association having served in different capacities. He has discharged his duties with utmost dedication, sincerity, honesty and diligence and has significantly contributed to the growth and success of our beloved Association.

Comrade Tushar Kanti Ghosh, joined the bank on 14.01.1986 as Clerk-cum-typist at Beliaghata Branch. He was promoted to supervisory cadre on 1st August, 2003. Prior to his promotion, he was Unit Secretary of SBISA at Beliaghata Unit (1998-2003) where he honed his organisational skills. After his promotion, he was posted at Rangat Branch (A&N Islands) until 2006. After repatriation to his home module, he was posted at Baguiati Branch, from where he became an activist of the SBI Officers' Association (Bengal Circle) and was vested with the responsibility of the Unit Secretary of the Composite Unit. He was promoted to MMGS-II in November, 2006 by the Bank in recognition of his exemplary performance as an officer of the Bank. On account of his devotion and sincerity as an activist of the Association, he was identified to shoulder the responsibility of Zonal President, Zone – 9 in 2008 (equivalent to current Regional tier of the Association) and thereafter as Zonal Secretary, Zone - 9 in 2009. In appreciation of his calibre to take on higher responsibilities in the organisation, he was elevated to a Member of the Administrative Zonal Committee, Bidhannagar Module in 2010. His commitment and dedication to the cause of the membership further elevated him to the post of Zonal President, of the newly established Corporate Module in 2015. He was included in the Central Committee in 2017 and was entrusted with the responsibility of Assistant General Secretary, South S24Pgs. Module for a brief period. Since 2019 he was made the Assistant General Secretary, Bidhannagar Module and in 2020, he was made the Assistant General Secretary, Corporate Module. From 2021 to 2024 he was again made the Assistant General Secretary, Bidhannagar Module, which was his home module as well. As a final feather to his cap, the Circle Association, thought it prudent to elevate him to the post of Vice-President of the Circle Association in 2024, a post he has held till he hung up his boots.

Throughout his illustrious career in Association, he has proved his mettle with his calm and composed outlook, wisdom, wit and experience. He always played key role in organising different organisational programmes and activities. He has a passion for travelling and possesses a keen interest in drama.

His retirement will leave a definite void in the Association, which would be very difficult to fill in.
